WIN DEREK'S BRONCO RAPTOR

- 1. Win Derek's Bronco Raptor™ promotional giveaway is a joint casino promotion for patrons of Circa Resort & Casino, the D Las Vegas and Golden Gate Hotel & Casino. The promotion runs from February 1, 2025 until October 31, 2025 with nine (9) monthly qualifier drawings. One (1) drawing will take place on the last Friday of each month May October. The qualifier earning period begins on February 1, 2025 at 12:00 AM and ends on October 31, 2025 at 6:30 PM. The grand prize is one (1) Bronco Raptor and the giveaway of this Bronco Raptor to the winner will be on November 22, 2025. In order to participate and win, patrons must be a Club One ® member ("Participants"). The winning Participant must be present at the final drawing to win and claim Derek's Bronco Raptor.
- 2. Participants earn drawing entries as follows:
 - a. One (1) drawing entry for every 100 points earned playing slots or video poker.
 b. One (1) drawing entry for all players at the table who have a minimum \$25 wager anytime a blackjack is dealt, including a dealer blackjack. Maximum of one (1) drawing entry per person for the hand. Does not include split hands.

Tickets earned playing slots or video poker may be claimed at the respective Club One location during regular Club One hours. Participants must present their Club One card to a table games dealer or table games supervisor to receive credit for table game play. Tickets earned playing table games will be distributed directly from table games pit management. Tickets earned playing keno will be distributed directly from keno management (the D Las Vegas only). Tickets are non-transferable. Points can be combined between Circa Resort & Casino, the D Las Vegas and Golden Gate Hotel & Casino to earn tickets. Participants whose play qualifies for an entry into Win Derek's Bronco Raptor will get their choice of either entering into Win Derek's Bronco Raptor or any different casino promotional giveaway with the same criteria during this time period.
- 4. Three (3) winners advance each month into the grand prize drawing barrel. 8. Drawing barrels are located at Club One at Circa Resort & Casino, the D Las Vegas, and Golden Gate Hotel & Casino. Drawing barrels will each close for entries at 6:30 PM, thirty (30) minutes prior to the monthly qualifier drawing. On the day of the monthly qualifier drawing, all entries will be combined in up to two (2) drums at Club One inside the property hosting the drawing. If two (2) drums are used, two (2) names will be drawn from each barrel for a total of four (4) qualifiers and (4) second chance entries. No drawing entries will be accepted after the drum closes. All nonwinning tickets are discarded at the end of each monthly drawing. Participants do not need to be present to win monthly qualifier drawing. Winners not present will be notified by contest officials. - 10. Bronco Raptor GRAND PRIZE GIVEAWAY DRAWING will occur on Saturday, November 22, 2025 at 4:00 PM. MUST BE PRESENT TO WIN GRAND PRIZE. The total of monthly qualifier winners who are present for the grand prize drawing, and have checked in with contest officials, each receive one (1) box for each of the qualifying grand prize drawing tickets the contestant has in the final barrel. One of the boxes will have the key to the Bronco Raptor and the person whose box contains the key is the winner of the contest. Tickets will be drawn randomly from the final drawing barrel to determine the order the contest participants will select a box. Each contestant will receive one box per final drawing entry.
